**A: Schedule to Conditions of Entry**

<b>Promotion Period</b>	The Promotion starts at 00:00:00 on <b>13<sup>th</sup> February 2025</b> and closes at 23:59:59 on <b>2<sup>th</sup> April 2025</b> .
<b>Eligibility</b>	The Promotion is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Promotion Period and with a valid identification document and residential address in Malaysia. ("Participant").
<b>Entry Method</b>	<p>1. ## WINNER SELECTION AND SHORTLISTING METHOD:

### A. Grand Prize: 5 x Panasonic Powerful Multifunction Grill Steam Microwave Oven 27L worth RM2299

There are **five [5] x Panasonic Powerful Multifunction Grill Steam Microwave Oven 27L worth RM2299** to be won throughout the Promotion period.

The rounding formula will be performed where the decimal value arises, the number will be rounded down to the nearest single digit number.

### B. Weekly Prize: 20 x Lotus’s Cash Voucher worth RM100 each ( x 6 weeks)

**Shortlisted Entries**

### **3. Eligibility**

3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organiser), from their parents/legal guardians before participating in the Promotion and submitting any personal information.

Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 (“Nestlé Malaysia Group”), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant’s participation in the Promotion, acceptance of any Prize, and/or the use of the Participant’s entry and/or likeness in connection with the Promotion or violation of the Terms and Conditions.

## **10. Limitation of Liability**

11.5 Where the Terms and Conditions of the Promotion is prepared in English and any other language(s) in the event of any inconsistency between the English language and the other language(s), the English language version shall prevail and govern in all respects.
